The Louisville Dog Run Association (LDRA) had a very successful year in 2014. The big addition to the dog park network was the opening of the Elizabeth Cleland Cauley Dog Park in Wendell Moore Park in Oldham County. This is the first facility our organization has established outside of Louisville Metro. A number of improvements were made to the facility over the course of the year thanks to the Elizabeth Cleland Cauley Foundation and Oldham County Parks and Recreation. These improvements include the construction of a gazebo, running a water line to the site and installing a people/pet combo water fountain.

The LDRA continued to work with Councilman David Yates and Metro Parks on the planning and construction of the Waverly Dog Run in Waverly Park (on Arnoldtown Road). Work on the facility has been steady and we anticipate the facility to be up and running in the first quarter of 2015.

Dog park membership increased slightly from 2013, going from 3,417 permits issued to 3,504 permits issued. The table below includes a breakdown by facility as well as the amount of rent owed for each facility.
